1. Purpose

The procedure established for suspension, withdrawal or reduction of the scope of halal certification in case when the client's certified management system has persistently or seriously failed to meet halal certification requirements. This SOP is developed to ensure compliance with PS 4992/OIC SMIC-2

2. Scope

This procedure applies to the PHDA issued certificates. This SOP applies to all certification activities, including surveillance, evaluation, review, and certification decisions involving the suspension, withdrawal, Terminate or reduction in scope of Halal certification.

3. Terms & Definitions

- **Nonconformity:** Failure to meet the certification requirements.
- **Suspension:** Temporary invalidation of certification pending corrective actions.
- **Withdrawal:** Permanent invalidation of certification/ Permanent retraction of the certification services and terminate contract
- **Reduction in Scope:** Removal of specific product variants or processes from the certification scope.
- **Re-audit:** Compliance Assessment /audit after suspension or withdrawal

4. Policy (Conditions for Suspension / Withdraw /Scope Reduction of Certification)

PHDA will suspend/withdraw /scope reduce of certification in following cases;

- a. Sharia offences are offences involving Sharia laws such as using Haram material, mixing/storage of Halal and Haram material together after receiving certificate from PHDA;
- b. Technical offences such as relocation of premise/factory, change of management and name of company without informing PHDA;
- c. The client's certified management system has persistently or seriously failed to meet halal certification requirements, including requirements for the effectiveness of the management system;
- d. The certified client does not allow surveillance or recertification audits to be conducted at the required frequencies;
- e. The Organization did not complete, correction/corrective actions within agreed time scale;
- f. The Organization fails to comply with the financial requirements of the agreement of certification; Misuse the Certification mark & violation of certification regulations;
- g. The Organization fails to conform with the agreed standard consistently;
- h. Willful non-compliance to the terms and conditions specified in agreement;
- i. Insolvency of the certificate holder or non-payment of liabilities.

- j. The certified client has voluntarily requested a suspension;
- k. Any other reason that PHDA certification authority realize the call of suspension, scope reduction or withdrawal of certification.

5. Responsibilities

- a) Chairman PHDA is the final authority to take any decision regarding suspension, withdrawal, or reducing the scope of certification. Chairman PHDA is authorized to may delegation of authority to committees or individuals, as required, to undertake defined activities on behalf of top management.
- b) The Halal Certification Board will give only their suggestion/recommendation to PHDA, to make the suspension, withdrawal or reduction decision.
- c) MR are responsible for sending warning, suspension and withdrawal letters and notifying the client.
- d) DMR is responsible to manage all related activities and documentation.

6. Procedure (Conditions for Suspension / Withdraw /Scope Reduction of Certification)

- 6.1 Under suspension, the client's management system certification is temporarily invalid, (Suspension Period shall be within 06 months).
- 6.2 PHDA will have enforceable arrangements with its clients to ensure that in case of suspension the client refrains from further promotion of its certification.
- 6.3 PHDA will make the suspended status of the certification publicly accessible.
- 6.4 Failure to resolve the issues that have resulted in the suspension in a time established by PHDA will result in withdrawal or reduction of the scope of certification.
- 6.5 PHDA will give 3 months written notice or such shorter notice as the situation may require depending upon the information available to PHDA.
- 6.6 PHDA have Publically assessable status of suspended and withdrawn clients on web site and, after suspending, and cancellation letter if the client not answering any related communication (suspending, withdrawing and cancellation letter).
- 6.7 PHDA will reduce the client's scope of certification to exclude the parts not meeting the requirements, when the client has persistently or seriously failed to meet the certification requirements for those parts of the scope of certification. Any such reduction shall be in line with the requirements of the standard used for certification.
- 6.8 PHDA has some contractual arrangements which ensures that the client organization, upon suspension or withdrawal of its certification, shall discontinue its use of all advertising matter that contains a reference to certification; shall amend all advertising matter when the scope of certification has been reduced; does

not imply that the certification applies to activities that are outside the scope of certification.

6.9 Upon request by any party, PHDA shall correctly state the status of certification of a client's management system as being suspended, withdrawn or reduced.

6.10 A checklist of for status of Client will be developed and will be communicated to IT department on fortnightly basis further existing procedure for Withdrawal or suspension of certificate will be updated for inclusion of web status.

7. Re-Audit

7.1 Client due audit (Stage II or Surveillance) will be conduct in case of less than 3 months suspension of certificate.

7.2 During a re-audit within 3 months the recertification audit may require less time on-site than the certification audit.

7.3 A stage II / re-certification audit will be conduct in case of more than 3 months suspension of certificate.

7.4 During a re- audit more than 3 months all elements of the entire management system will be audited.

7.5 If a successful re-audit does not occur, the certification will be withdrawn.
